Purchaser must supply professional sound, lighting, and performance equipment including:

- Two (2) Technics 1200/1210 turntables (working start/stop, accurate pitch, stereo output). **WITH SERATO**
- Rane TTM 57 or Pioneer DJM-800 Mixer (**WILL NOT PERFORM W/O ONE OF THESE MIXERS**)
- PIONEER CDJ 1000 MK2 turntable (placed to right side of turntables)
- Complete Serato setup (interface box and all cables)
- ONE (1) working microphone to be sound checked for DJ use (prior to DJ arrival)
- ONE (1) sturdy laptop stand, preferably mounted above mixer
- All sound INCLUDING SERATO to be installed and sound checked prior to artist's arrival at venue
- TWO (2) loud stage monitors setup in STEREO w/ DJ CONTROLLABLE VOLUME
